1. Release Features

Overview

The following new features and modifications are included in this release.

The HealthLink Messaging Client is now a 64bit service. This change supports recent and future increases in New Zealand and Australia message standard payload sizes where messaging processing memory requirements are greater than 32bit service addressable capability.

These messages have increased payload size with this released

- NZ GPTOGP
- HDOC

This and future releases will not support 32bit Operating Systems requiring customers to upgrade to a 64bit OS before installations.

2. Resolved Issues

Overview

The following outstanding issues are addressed in this release.

HMS2-811	HMS Client Update Nullpointer Exception while downloading the update package
HMS68-65	Warning for Quantum web admin missing
HMS68-2	Debug mode is accidentally turned on after migrating log4j to log4j2



3. Known Issues

Overview

The following issues found during testing of the HMS client have not been resolved in this release.

Ticket	Description
HMS68-57	Form submission intermittent failures under load.
HMS68-53	ESA submission using the old expired self-signed certificate.
HMS68-89	The Quantum service failed to start after applying the quantum update patch.
HMS68-90	HMS Client not using cache for HL7 messaging capability lookup
HMS68-91	HMS Client cannot be manually run 'in between' the sleep period interval in Always On Mode
HMS68-92	Adding new users without using copy selected profile causes a processing exception - Configuration settings could not be found
HMS68-93	Base directory not set correctly when adding new EDI account from HealthLink Advanced Options



4. Enterprise Solution

5. Rollback

Overview

To restore the site to the previous build, perform the following process.

- 1. Uninstall HMS 6.8 using the uninstall program.
- 2. In the event the HMS 6.8 was aborted or was partially installed (resulting in no uninstall program being available) then use the repair install option to restore the client.
- 3. Reinstall HMS 6.7.3, or the previous version if not HMS 6.7.3, following the HealthLink reinstall process.
- 4. Re-apply patches. Refer to customer support for these details.
